Some of you have asked about the judging at the NW Food and Wine Festival and I am enclosing a entry form here along with instructions.

Going into our 4th year with the NW Food and Wine Festival most of you are aware of our commitment to promoting the wineries of the Northwest. I get asked all the time which non-profit does the event benefit, and although we do benefit the Make it Better Foundation promoted by the Blazers this year, our focus since the start of the event 4 years ago was to benefit the wineries and restuarants right here in the Northwest that participate in the event. With that in mind we decided to take the NW Food and Wine Festival to the next level with a judging opportunity for wineries.

Entry Information & Deadlines.

An official entry consists of 2 bottles of 750 ml each

There is no restriction to the number of wines a winery may enter.

There is a 25.00 charge for each wine entered.

Registration entries close on October 23rd, and all wines must be received by that time.

Judging:

Wines will be judged by a group comprised of wine professionals: wine makers, winery principals, restauranteurs, sommeliers, wine journalists, members of the wine trade and serious wine collectors. All judges will be under the supervision of the Chief Judge, who will make all judging assignments and arbitrate disputes.

Categories or Class:

Cabernet 01, Cabernet Blend 02, Merlot 03, Merlot Blend 04, Syrah 05, Pinot Noir 06, Tempranillo 07, Chardonnay 08, Riesling 09, Pinot Gris 10, Sauvignon Blanc 11, Viognier, Rousanne 12, Semillon 13 and Port 14. Wines submitted for which there is no existing category will be entered in an appropriate category created the Chief Judge.

Awards:

Wines in each class will be considered for Platnium, Gold, Silver, or Bronze Medals, and a "Best of Show" will also be awarded.
